

New Education Advocacy Program Aids Families With Special Needs Children



The Arc of Somerset County launched a new program called Education Advocacy to help parents and guardians of children with special needs develop and maintain an Individualized Education Plan (IEP). This fee-for-service program assists parents in developing both a strong working relationship with school officials and a mutually supportive learning environment.

Education Advocacy will help parents and guardians formulate a strategy for IEP participation and review, advocacy at mediation hearings, telephone consultations, and letter writing. The Somerset Arc's goal is to keep guardians informed so that they can seek the support that is appropriate and available by law.

"Thanks to their donation, and donations from other benefactors, we improved the quality of life for 38 children in our daycare programs and for 192 children in speech and physical therapy. We improved six cabins at Camp Jotoni for 170 children and young adults, and assisted 303 adults in Employment Services."

The number of people with special needs is growing. Currently, The Arc faces a major challenge transporting clients from home to worksites and medical facilities. Explains Bonnie, "Eighteen vehicles need replacement. A third of those require wheelchair lifts, which adds \$25,000 each to the replacement cost."

Thanks to determination and hard work, not to mention early intervention, a former Arc consumer is now earning a 3.4 grade point average at Kutztown University!


At age 2, Jimmy still wasn't speaking. He would stomp away from his parents, unable to communicate his needs. A professional diagnosis identified the cause as delayed speech and possibly attention deficit disorder (ADD). Jimmy's parents turned to The Somerset Arc's Early Intervention Program (EIP) for help.

An EIP team consisting of a Speech Language Pathologist, Special Education Teacher, and Physical and Occupational therapists taught Jimmy coping and communication skills.

Their mutual success prepared Jimmy for the Somerset Arc's Preschool Disabled Program.

"Jimmy had a hard time concentrating," his father says. "School gave him ways to organize, which was his biggest challenge." Much to his parents' relief, at age five, Jimmy qualified for a pre-kindergarten class. And by age 14, he no longer qualified as disabled.

Jimmy has since graduated from Somerville High School, attended Kutztown University, and is transferring to Rutgers University. Last semester, he earned a 3.4 Grade Point Average (GPA)! Congratulations to Jimmy and his parents!

- A revised Strategic Plan spearheaded by our CEO and department directors.
- A growth in new grants, corporate sponsorships (thanks to long-term friends of The Arc), and donors adding to The Arc's excellence and sustainability.
- Approval of Judy's campaign to provide staff with ad-

- ditional training and recognition, compensation, and one-on-one care.

KEEPING AN EYE ON PREVENTION

HALF OF THE 350 CAUSES OF MENTAL RETARDATION ARE PREVENTABLE!

During hot weather, the temperature inside a car can exceed 100 degrees in seconds! That's why The Arc of Somerset County adopted a consumer safety policy entitled, "Not Even For A Minute." Windows opened a crack does little to alleviate

a suffocating surge in temperature. Never leave anyone in a hot car, not even for a minute! If you see a child left alone in a car, look for the parents. If the parents cannot be found, call your local police or ambulance for help.

Nov. 4 Meeting To Explain Changes in Medicare and Medicaid

The 2006 budget passed by the NJ Senate and Assembly provides funds for The Arc's top three priorities: removing the Medicaid co-pay, funding a wrap-around for dual eligibles (Medicare and Medicaid), and addressing an increase in the cost of providing care. A meeting to explain the impact of these budgetary changes on Medicare and Medicaid recipientshas been set for Nov. 4 from 10 a.m. to 1:30 p.m. at the Somerset County Library. Call 908-725-8544 x 607 to pre-register.

Says Liz Shea, Director of The Arc of NJ's Governmental Affairs, "While we certainly would have liked to receive more than the 1.5 percent rise in the cost of providing care (1 percent

from the budget and .5 percent from the Department of Human Services), in today's fiscal and political environment, getting anything was a miracle."

Liz Shea credited Tom Baffuto, New Jersey Arc's Executive Director, for contributing an "astounding" amount of time and energy to this effort. "I feel fortunate to have his leadership," she said. Liz also thanks The Arc's staff, consumers, families, and supporters. "Our success comes entirely from our shared advocacy statewide," she said. "We couldn't have done it without each and every one of you!"
