Message from the Executive Director

Dear Family, Friends & Colleagues,

As we reflect on FY 2016, we are thrilled to share with you how The Arc of Somerset County continues to be a leader in disability advocacy and services in the community. On a county level, The Arc of Somerset County has launched important new projects in areas that showcase our expertise in the disability field.

In the fall of 2015, we launched the pilot phase of our new College based program, "The Achievement Center". Located on the campus of Raritan Valley Community College, The Achievement Center offers young adults with disabilities the opportunity to attend college alongside their peers in a supportive and collegiate environment. The goal for our students



is much the same as any other college student, to engage in new experiences and relationships that will eventually guide them towards gainful employment and a career path. In the fall of 2016, the full roll out of the program will begin as well the initiation of new partnerships with several local high schools.

With the State of New Jersey moving towards a Fee for Service system, The Arc has begun to offer new services that will provide enhanced supports to individuals in the community. Two of our new programs are based out of our PACT (Parents and Children Together) program and are designed to provide intensive in home supports to children ages 5-21 who are experiencing difficulty with daily living skills and emotional / behavior challenges. The program's goal is to work with the child in their natural setting, while also increasing the skills of the parents and the success of the family as a whole.

Our children's services have also had an active year, participating in the "NJ Race to The Top" initiatives to help develop a rating scale for childcare providers and to help enhance the quality of daycares across the state. Our Jerry Davis Center for Children and Families was one of only a handful of centers chosen to participate in the pilot phase of this initiative – and we are the only child care center that serves children with disabilities in the pilot. In addition, on November 24th, 2015, The Jerry Davis Center for Children and families was awarded the 2015 Disability Advocate Award by the Somerset County Freeholders for their outstanding work in supporting and promoting children's educational, social and emotional well-being through their program offerings.

This past year we also continued our commitment to self-advocacy, which is a vital aspect of our work. Our sef advocates participated in several important initiatives that will further our efforts to ensure that all individuals, regardless of ability, are given the opportunities and rights that all community members enjoy. The Arc of Somerset County's self-advocates were awarded an advocacy award at the State Self Advocacy Annual Luncheon and several of our self advocates efforts were acknowledge through individual awards. Our self advocates are at the heart of our organization and they have worked tirelessly and passionately to move our mission and vision for individuals with disabilities forward.

While FY 2016 presented us with its share of challenges, The Arc has been fortunate to achieve new gains on behalf of the community we serve, exceeding even our own high expectations.

Please join us as we look back on this year of tremendous growth and look forward to another outstanding year of service in FY 2017.





Early Intervention Childcare & Family – A Partnership for Success

Emma started childcare at The Jerry Davis Center for Children and Families in late December 2015 at the age of 27 months. Her parents were anxious to put her in a school environment and hoped she would adapt to a new setting. She was placed in the toddler room and began learning to focus within activity areas, and socialize with other children. She exhibited some signs of anxiety and fearfulness in this new environment with structure and demands. When she started, she wore a sensory pressure vest and demonstrated her own stubborn agenda and transitional issues.

Emma received Early Intervention services from The Arc of Somerset County practitioners to address needs in speech, fine motor and sensory issues, behavior and processing. Many of the services occurred in the classroom and the strategies are mirrored by her teachers. Quickly the combination of the small ratios, the partnership with Early Intervention, knowledgeable classroom staff and communication with the family began to pay off. Emma moved to the pre-school class and began to expand her social and language world. In a few short months she has learned to choose activity centers and play within that area by herself and with other students. She enjoys the freedom of the art center and the fun with others in the music center. Emma now uses a full sentence to request items and punctuates with 'please' and 'thank you'.

Emma's parents value the attention The Arc gives to Early Intervention practitioner placement and assignment. They communicate well with the staff and appreciate the interactions between Early Intervention practitioners and classroom teachers, especially with the language and sensory strategies that are reinforced regularly.

Emma has grown to know and respond to the expectations and routines. She no longer needs a pressure vest to maintain composure and regulation. The schedule and attention has given her confidence in knowing what is next and what she is capable of doing. Today Emma is a successful, happy little girl who demonstrates increased spontaneous language, is comfortable with peer play, and enjoys running around with her girl friends, twirling scarves and dancing to Taylor Swift.

In-Home Clinical and Therapeutic Services

The Arc of Somerset County is qualified by the State of New Jersey to provide Intensive In-Home Clinical and Therapeutic Services and In-Home Individual Support Services to children and youth up to the age 21 with developmental and/or intellectual disabilities who may also experience emotional and behavioral issues.

The goal of both of these face-to-face services is to:

 Assist children and youth in acquiring, retaining, and improving the self-help, socialization, and adaptive skills needed to function successfully in home, at school, and in community based settings.

Services Include:

- Intensive In-Home Clinical and Therapeutic Services delivered by licensed clinicians to children and youth who have experienced an acute episode of physical or mental disability or a long term mental illness.
- Individual Support Services assist children and youth who exhibit challenges when
 performing Activities of Daily Living (ADL) which are described as skills related to daily
 self-care activities such eating, dressing, personal grooming, safety and community
 awareness, housework, managing money and communications.





Intensive In-Home Therapy

Beginning in 2015, The Arc of Somerset County began offering two state approved fee for service programs to children and youth up to the age 21 with developmental and/or intellectual disabilities who may also experience emotional and behavioral issues: Intensive In Home Clinical and Therapeutic Services and Individual Support Services. The goal of both of these face-to face services is to assist children and youth in acquiring, retaining, and improving the self-help, socialization, and adaptive skills needed to function successfully at home, school, or in community based settings.

Raul" is a 19 year old young man who lives at home with his parents. He enjoys basketball and baseball and is looking forward to graduating high school and getting a job. He has a developmental disability and receives special education services. As Raul grew older, his emotions became more intense, the interactions with his parents became more challenging. His parents realized they required assistance to understand more about the emotional and behavioral needs of their son.

His parents contacted the NJ Children's System of Care, the agency that is committed to ensuring children, youth, and young adults receive the behavioral healthcare they need. The Arc of Somerset County received the referral and a Family Interventionist began providing Intensive In Home Clinical and Therapeutic Services to Raul and his family. The services concentrated on helping him learn anger management skills such as deep breathing and redirection. He has learned to use these coping skills to calm himself down when he gets angry and in just over six months the interactions between Raul and his parents have improved significantly.

While in the home, the interventionist realized that Raul could also benefit from Individual Support Services, which assist children who exhibit behavior challenges when performing Activities of Daily Living (ADLs) such as eating, dressing, personal grooming, and use of telephone. He was approved for these additional services and has another Family Interventionist working with him and his family in the home. Although these interventionists work on different goals, they coordinate their services so all skills are reinforced.

Raising a child with a developmental and/or intellectual disability can challenge a family's ability to cope. The strategies and services that are now provided are brought together to foster stability and to enhance the quality of life for Raul and his family.

Adult & Senior Services





The Arc provides a range of services for adults with intellectual and developmental disabilities that allow each individual the opportunity to live, work, and recreate in their own way. We provide:

- Safe and healthy places to live in the community.
- Employment opportunities ranging from center based work to community-based jobs.
- Specialized services to meet the changing needs of our persons-served as they age.

The Arc Supports New Friendships with Community Members

The Arc of Somerset County believes that each person we serve will have the opportunity to live and participate in the community regardless of the level of her/his abilities. We further believe that each person deserves the opportunity for meaningful relationships with family and community involvement, at all levels.

Our story is about Danny and his new relationship with a Branchburg Family from the Somerset County Community. This past year, one of our long term residents, Danny, experienced a new found friendship with his Camp Jotoni counselor, Ashley. Ashley is a second-year nursing student at Raritan Valley Community College who took a summer job at Camp Jotoni during the summer of 2015, and immediately experienced the rewards of working at a special needs camp. Ashley's specialty of nursing and one-on-one care, made her a perfect match to work with Danny. Her connection with Danny went so well, that they both felt a deep sadness when camp season came to a close, and decided they would stay in touch over the fall and winter months.

During this time, Ashley shared her friendship with Danny with her boyfriend JR and his family. JR's parents, Brenda and John and sister Victoria were very inspired by meeting Danny and suggested they all attend church on Sunday at Stonecrest Community Church in Warren Township. A church outing led to a mall outing, which then led to a family holiday gathering and now, Danny visits with the family almost every other weekend.

Danny's high-spirited demeanor has been evident since the start of this new family friendship with Ashley and JR's family. He looks forward to future outings and experiences and enthusiastically speaks of them as his "Family". The Arc of Somerset County continues to encourage the community at large to develop friendships with the adults we serve and wishes Danny much happiness with his new family friends.

The Achievement Center at Raritan Valley Community College



The Achievement Center at Raritan Valley Community College provides students with intellectual and developmental disabilities the opportunity to participate in a fully inclusive college experience.





This transitional post-secondary program is a collaboration between The Arc of Somerset County, Raritan Valley Community College, and The Arc of Hunterdon County.

The Achievement Center at Raritan Valley Community College Pilot Two Successful Semester

The Arc of Somerset County is proud to enter its second year of partnership with Raritan Valley Community College (RVCC) and The Arc of Hunterdon County this upcoming September. "The Achievement Center" at Raritan Valley College is a three year post secondary educational program for students who recently graduated from high school or who are exploring options in their final high school year. The Center, which recently completed its pilot semesters, will welcome 11 new and returning students in the Fall of 2016. Offering advanced experiences in preparation for greater or more sophisticated employment outcomes as well as exposure to accessible college courses in the liberal arts and college life. Current Achievement Center students have already completed inclusive college courses, developed college plans and enrolled in computer literacy courses. Students attend classes designed to create both a college education and career plan while gaining access to the social and interpersonal experience of a busy college campus.

Students work with a peer mentors from the RVCC community and join increasingly more integrated subject classes as the three year program progresses. As part of The Arc of Somerset County's Employment Services Department, The Achievement Center brings the assessments, job exploration and preparation activities typically associated with the job search process into an academic environment to allow students to develop their preferences and skills at a level offering more time and depth. Success in our first year has included a partnership with The Student Development Course Committee, an expansion to bring initial classes to area school districts and other community providers and our first student for-credit grade in an inclusive RVCC class. The Arc of Somerset County and its partners wish our new students well for the Fall of 2016 as they embark on the next phase of their learning life. Congratulations!


Social skills are an underlying theme to our programs in order to encourage growth and development for all campers.

For the past two years, Camp has seen significant growth in enrollment, which has led to the expansion of our program offerings and the hiring of additional staff, including international staffers.



At the start of 2015, Camp Jotoni launched their first online application process for registration which streamlined the process for both our families and our staff.

2016 also marks the 40thyear of service of Camp Jotoni. A celebration is planned for August 28th with a family and alumni party at the camp.


