
qualified and diverse group of directors, and I look forward to working with them this year.

## **Volunteers Buddy Up with Residents**

Since the Spring, a Buddy Program has been blooming at The Arc of Somerset County. Volunteers age 17 and older are being matched with residents by location, skills, and mutual interests. As a result, friendships are thriving. "Volunteers provide a wonderful extension to the services provided by staff members," explained Tara Abbott, Assistant Director of Development. "Volunteers offer residents companionship and the opportunity to hang out and have fun."

One volunteer from Hillsborough High School taught an Ardsley Group Home resident how to hook up her laptop and navigate the Internet. Another volunteer accompanied the Cambridge Group Home residents on a walk to the park. "The program is getting rave reviews," Tara said. "Volunteers are asking to spend more time with residents, and residents are enjoying the extra attention."

Chris Gunning, Director of Residential Services, described the variety of volunteer opportunities that are available:

- Corporations send volunteers to help maintain Arc facilities
- Raritan Valley Community College students participate in Service Learning

- Churches and schools adopt and help refurbish Arc residences
- Pediatric residents from the Robert Wood Johnson Medical School have completed internships at the Jerry Davis Center for Children and Families
- Individuals are buddying up with residents in group homes "Some of the volunteers inquiring about the Buddy Program are students returning from the Service Learning Program," Chris noted. "These students are gaining hands-on experience in the field of social services." Other volunteers include retirees looking to give back to the community, newlyweds, caring individuals, and a mother-and-daughter team.

The Buddy Program is spreading enthusiasm throughout The Arc community. "Residents are finding out about the program and asking for volunteers," Chris said. "They are beginning to initiate these friendships."

# **Advocacy Conference Highlights Benefits of Social Media**

Among the accomplishments and issues discussed was the ongoing campaign to end the use of the "R" word. After the general meeting, participants attended two workshops of their choosing.

Workshop topics included: understanding the role and services of the Division of Developmental Disabilities; tips on public speaking; and networking through social media. "One self-advocate diagnosed with cerebral palsy uses Twitter to blog about disability issues," said Tara Abbott, Assistant Director of Development, who conducted the Social Media workshop. "He has attracted thousands of followers!" Staff as well as self-

# **Supported Living Group Launches Book Club**

On November 20, the Supported Living Club (SLC) held its first bi-monthly meeting of the Book Club at the Valley Park Adult Training Center in Hillsborough.

"Members of the group realized that many residents enjoy the same books and movies," explained Sharon McClellan, MSW, Director of Clinical Services. "We thought it would be fun to have a theme evening complete with popcorn, a film, and a half-hour discussion of what everyone liked and disliked about the story."

The SLC took a trip to the Manville Library and chose a large selection of books that have been made into movies. The library has agreed

to set copies of the books aside. The books selected by group members Barbara Blair, Robert Burgess, Barbra Cornelius, and Brian O'Malley, all of whom are living in apartments in Manville, will be posted on The Arc of Somerset County website.

Book and Movie Nights are open to individuals of all reading abilities, including members of the community. Participants are encouraged to familiarize themselves with the books in the easiest way possible. Participants can read the books, ask family members or staff to read the books aloud, listen to Books on Tape or CD, or watch the movie.

Every Tuesday, members of the SLC meet to plan an event or discuss a topic of interest. In September, the group held its first monthly meeting of the Cooking Club at The Arc's main office in Manville—and, with the help of Suman Paul, Support Specialist of Clinical Services—learned to cook lasagna. "Group members are always

coming up with fun and creative ways of building their skills," Sharon said.

Over the years, Eddie held several jobs. He was an avid Mets fan and a devoted member of the Reformed Church in Franklin Township.

# JOAN SAPIENZA IMPROVES COUNTLESS LIVES

"Having a summer camp was Joan Sapienza's dream, and now it is her legacy," said Lauren Panarella, Executive Director, at a Celebration of Life and Memorial Service at Camp Jotoni on September 20. "Joan promoted both the purchase of this land and the development of a camp program. And it was her wish to have a service here."

Joan Sapienza, the first Executive Director of The Arc of Somerset County in 1974, passed away on April 6. Nearly 100 people attended her service, including former and current board members, staff members, Arc clients, and family and friends, many of whom traveled to Camp

Jotoni from Vermont. In her opening comments, Lauren quoted a poem, author unknown:

You can shed tears that I have gone, Or you can smile because I have lived

You can close your eyes And pray that I'll come back, Or you can open your eyes, And see all that I have left.

Other speakers included John Ridley, former board member; Chris Reagan, Director of Camp Jotoni; Fred Patterson, founding parent of the camp; and Lou Baldino and John Horan, former Arc Executive Directors. The speakers described Joan's fierce dedication and commitment to individuals who have developmental disabilities, her ability to inspire people, and her understanding of a family's need for alternatives to institutional care for loved ones.

Joan has made a significant difference in the lives of countless individuals and their families. Said Chris Reagan, "Every summer, nearly 200 visitors participate in our summer programs at Camp Jotoni. We have campers who have been coming here for 23 years. Some of them come from other counties and states. Joan's dream has been realized."

Joan's husband, Vito Sapienza, dedicated a beautiful print that had been given to Joan on her retirement to The Arc of Somerset County. The print, created by disability artist Martha Perske, will hang in the reception area at the headquarters in Manville. In addition to her husband, Joan is survived by sons Lewis, Andrew, Peter, and Mark.

As a tribute to Joan's strength, determination, and vision, a red oak tree was planted at Camp Jotoni and dedicated to her memory.

It is with heartfelt gratitude that Eddie and Joan will be remembered and loved.



# **Governor Corzine Declares DSP Recognition Week**

Governor Jon S. Corzine issued a Proclamation designating September 14 to 19 as National Direct Support Professional's (DSP) Recognition Week. The Proclamation demonstrated the Governor's commitment to offer DSPs the education and compensation essential to ensure the success, independence, and quality of care for many of the state's most vulnerable citizens.

"It takes a lot of commitment to complete what is essentially a three-year college program," explained Lisa Intili, Director of Quality, referring to the Career Path Program. "There is a lot of studying involved, as well as practicing and applying new techniques. "DSPs who complete the

program will receive a title upgrade and an increase in compensation."

DSP Recognition Week was sponsored by the Elizabeth M. Boggs Center on Disabilities in collaboration with the New Jersey Division of Developmental Disabilities and the Direct Support Workforce in New Jersey.

Said Lauren Panarella, Executive Director, "A DSP's work is challenging, noble, and life-changing for those in their care. We attribute the success of The Arc of Somerset County largely to the dedicated and talented group of DSPs who provide a broad range of supports to the individuals served."

## **Eight DSPs Awarded Certificates of Achievement**

# Colleen Quinn Wins Making a Difference—DSP of the Year Award

Winning the Direct Support Professional Award feels wonderful to Colleen Quinn of the Jill Court Adult Training Center in Hillsborough. Colleen also received a Proclamation Letter from US Senator Robert Menendez. While she is genuinely grateful for the recognition, Colleen notes that her greatest reward comes from working directly with the clients who require her services. "Feeling their heartfelt thanks makes this very gratifying work," said the 45-year veteran. "This has to be a vocation, not a job. It's physically demanding work and has to come from the heart."

Colleen's passion for DSP work began when her daughter, now 49, was born with developmental disabilities. "There was not a whole lot happening in terms of programs and services," she said. "We have come a long, long way."

Remarked Alison Malnak of Employment Services, "Colleen helped our first Executive Director raise the funds to open our agency's first group homes and work centers." First hired in 1974, Colleen helped create and manage the first medical model: a work center capable of accommodating people who use wheelchairs and walkers.

Colleen is hopeful the Career Path funded by a grant from the NJ Council on Developmental Disabilities will attract and retain many DSPs who are qualified and dedicated to their profession. Said Alison, "Colleen is a role model for fellow DSPs who are completing the Career Path coursework. Her leadership has inspired many staff members to remain in this field, and to become managers themselves."

Colleen is happy that DSPs who complete the Career Path Program will receive a title upgrade and increase in compensation. "You shouldn't have to move into management to get increased compensation," Colleen remarked. "The hands-on work is where things really happen. Yet those who provide those services earn the least amount of money. And they have to earn a living too!"

"Providing DSPs with incentives for staying in direct care is the key to providing individuals who have developmental disabilities and their families with consistency of care and de-

pendable caregiving relationships," she added.



#### "Go For It!" Says Fred Patterson, Lifetime Achievement Award Nominee

Fred Patterson and his wife, Roe, cared for their daughter, Kathy, diagnosed with profound mental retardation, at

home for more than 30 years. "We were at the end of our ropes," said the Board Member-at-Large. "Caring for Kathy can be so difficult."

Fred urged state legislators to provide funding for residential services for at least some of the 8,000 individuals with developmental disabilities who are on a waiting list in New Jersey. Unable to convince the group, the retired Marketing and Public Relations

executive from Johnson & Johnson took matters into his own hands. "People warned me that going over the heads of legislators would be suicidal," Fred said. "But I went ahead anyway, and came up with 'A Key of Our Own' campaign."

As the former President of The Arc of New Jersey, Fred went straight to the voters with a multi-media campaign spotlighting his daughter. When highlighting the needs of individuals with developmental disabilities failed to persuade voters—because

the public had no personal connection to the disability community—he refocused the campaign to the plight of parents.

Fred's flexibility and perseverance paid off, when—with the support of former Governor Christine Todd Whitman—voters passed a \$160 million bond issue to provide residential services and staff to care for people with developmental disabilities. Subsequently, Fred was recruited to help other states achieve similar success.

This is only one of a long list of accomplishments that distinguish Fred's symbiotic career as executive, volunteer, and parent. And it is one of the reasons Fred has been nominated for the Lifetime Achievement Award of the National Conference of Executives (NCE) of The Arc. Other key initiatives of his include Safe Kids USA, which Fred co-founded, and the New Jersey Governor's Council on the Prevention of Mental Retardation and Developmental Disabilities, which he chaired for many years.

"After Kathy moved into a group home, many people thought Fred would slow down," said Maureen Babula, President of the NCE of The Arc. "But his mission will never be 'accomplished.' Fred sees advocacy for people with developmental disabilities and their families as lifelong—and life giving."

Fred credits his daughter for making him the "man he was meant to be." His advice to others who feel passionate about issues they think may be beyond any one person's ability to improve: "Go for it!"

# **Master Gardener Program Is Growing on Campers**

The first Master Gardener Program at Camp Jotoni left a delicious impression on campers of all ages, interests, and abilities. From daily nature sessions to "make your own pizza" with herbs and tomatoes planted in their first vegetable garden, "campers seemed to really enjoy it," said Christopher Corvino, Associate Executive Director.

The garden was planted by Jody Friedman and fellow Rutgers Master Gardeners including Jane Bernabe, Kathy Chapin (parent of Counselor-in-Training

Kyle Osterloh), Ivanka Gukunski, Sherry Howe, and Cathy Vassello—just before campers arrived. The Master Gardeners used plants and supplies generously donated by Walter's Garden Center in Bernardsville. Included were sage, thyme, oregano, tomatoes, peppers, beans, squash and a watermelon.

Campers learned the joys of a summer harvest when the vegetables

were ripe for picking in August. By then, campers had already developed greater sensitivity to their lush surroundings in Warren. "Thanks to the Master Gardeners, we were able to expand the nature aspect of Camp Jotoni," Chris said. "In addition to planting the garden, the group developed a curriculum of learning tailored to individuals at all levels of abilities." The curriculum included plant identification and safety, such as the detection of poison ivy, and sensory gardening.

"The most beneficial aspect of the Master Gardeners Program is that campers were involved from beginning to end, and could feel that they had really accomplished something," Chris Reagan enthused. Added Chris Corvino, "Campers were able to contribute to something that was uniquely theirs while, at the same time, expanding their knowledge and developing new skills. Campers could say, 'I helped grow this plant.' Or 'I helped prepare this dinner.' Or 'I know what poison ivy looks like.' "

Both Chris Corvino and Chris Reagan look forward to continuing and expanding the Master Gardeners Program
