A MESSAGE FROM THE Executive Director

The year 2004 has certainly been eventful for the state of New Jersey and agencies serving people with disabilities. In September, the governor's announcement of his resignation made nationwide news and continues to do so. More important to Arc consumers is that despite a huge budget deficit, agencies serving people with developmental disabilities obtained a significant increase in government funding.

Our funding increase of 4 percent is the largest in many years. Although that barely covers a portion of rising costs and affords only a slight increase in staff salaries, it was an important step in the right direction.

We owe this increase to the tireless advocacy of our human services community. I am proud that The Arc of New Jersey led this effort, and that the collective power of The Arc's chapters played such a significant role in our success.

Unfortunately, New Jersey is faced with another year of budget deficits. Deficit projections have grown even larger, and some of the strategies used

Sharon Booker Aims High and Succeeds

Live Right, Eat Right, Fly Right. Living by this personal mantra has led Sharon Booker to become a role model for anyone who wishes to overcome challenges and achieve healthy goals. The Arc of New Jersey honored Sharon Booker for her courageous self-advocacy and community contributions with the Bill Sackter Award at its 2004 awards celebration in Princeton on November 30. *(This award was named after Bill Sackter, a public speaker and entrepreneur who left the security of an institution for independent living. His dramatic achievements inspired the acclaimed television film, Bill.)*

Sharon not only recovered from a heart attack and losing custody of her only son, but she achieved a series of remarkable triumphs: dropping 150 pounds, ending dependencies on

multiple medications, working two jobs, and moving from life in an institution with 24-hour supervision to her very own apartment! As if these achievements were not enough, Sharon won a gold medal in the local Special Olympics (for the 100-mile walk, a softball throw, and the 50-mile walk) and silver and bronze medals in the state Special Olympics.

Dubbed a true inspiration, Sharon keeps learning and growing, as well as sharing good will with fellow consumers.

Presently she is aspiring to become a certified assistant in nursing, first aid, and CPR. She also aims to obtain a driver's license, a trust fund for her son, and a burial fund. Sensitive to the needs of others, Sharon spends time with Arc residents who rarely receive visitors.



Kim Artis and Tom Brooks Receive 2004 Arc Angel Awards



Workshop Aids Siblings of People with Developmental Disabilities

The Arc of Somerset County held a workshop at the Hilton Garden Inn in Bridgewater on November 9 to apprise families of disability law. Ira M. Fingles, from Hinkle & Fingles Attorneys at Law, addressed the concerns of siblings who must assume responsibility for people with developmental disabilities from aging parents.

An expert on disability law, Ira provided an overview of the adult service system and special education entitlements such as Medicaid. He also discussed issues relating to guardianship and estate planning.

In brief, Ira instructed families on how to assume meaningful responsibilities with the least disruption to daily life. Several attendees, including a lawyer and a CPA who has a child with autism, gave the seminar glowing praise.

Staff spotlighted the Manville center's five pivotal programs: Early Intervention for infants and toddlers; Developmental Daycare, Preschool Disabled, and Private Preschool for children ages three months to three years; and PACT (Parents and Children Together) for parents who have developmental disabilities. Therapist Donna Kelly aired a video that showed children participating in activities throughout the year.

The Jerry Davis Early Childhood Center's capable staff and comprehensive interdisciplinary programs appealed to visitors as a loving and a happy place for children with and without special needs to learn and grow during their formative years.

HALF OF THE 350 CAUSES OF MENTAL RETARDATION ARE PREVENTABLE!

Preparing a Progress Report on Prevention

The New Jersey Office for the Prevention of Mental Retardation and Developmental Disabilities together with the Governor's Council on Prevention are preparing to present a progress report to Acting Governor Richard Codey and the state legislature on June 10. It's been 20 years since these agencies published their first report: *Programs to Prevent Mental Retardation in New Jersey*. Says Fred Patterson, chair of the Governor's Council, "We are the only state that has a Governor's Council on




Prevention and an annual appropriation that supports ongoing initiatives, such as a three-year public education program."

Members of the state Office and Governor's Council have documented dramatic accomplishments resulting from their efforts.

- While lead poisoning persists in impairing children's health, development, behavior and learning, today, it rarely causes death and mental retardation.
- A \$450,000 appropriation and new state programs have reduced the number of children affected by prenatal exposure to alcohol.



- NJ's new bicycle helmet law for children (the first in this country) has significantly reduced the number of permanent brain injuries.
- New safety laws have made it mandatory to wear seatbelts while driving, place seatbelts in buses, and transport older-aged children in a car seat.




• Educational materials have alerted physicians and women that taking folic acid before and during pregnancy helps prevent neural tube defects.

- The screening technology for identifying newborns at risk of mental retardation due to genetic abnormalities has been greatly expanded and improved.





AIMING HIGH AND SUCCEEDING

The road to informed choice and community inclusion has been rocky at times. After her heart attack, Sharon was required to attend two years of counseling and to follow a strict diet. Sharon aimed higher by taking a two-year class in independent living. She passed the class, assumed a second job and earned enough money to travel to Virginia from New Jersey to visit her son.

Another two years of self-advocacy won Sharon the right to move into a supervised-living apartment. Overcoming challenges with roommates and her former care agency, Sharon sought advocacy from Michael Metaxotas who helped her become a resident of The Arc of Somerset County.

The Arc community is happy to bestow the Bill Sackter award on Sharon Booker. Congratulations Sharon, and thank you for paving the way for others!
