A MESSAGE FROM THE **Executive Director**

In February, NJ Governor Corzine released his proposed budget for the fiscal year 2008-9. Included was an appropriation of \$40.6 million to keep

the cost of providing services to people with disabilities at its current rate. However, given that the cost of providing care has increased, this amounts to a budget cut for The Arc of Somerset County as well as other service providers.

As an advocacy and service agency, it is our mission at The Arc of Somerset County to support the rights of children and adults who have special needs. To achieve our mission, we are facilitating a Self-Advocacy Group that is run by and for people who have developmental disabilities. (*See article to the right.*) We are also participating in government forums and partnering with legislators to establish laws that ensure the rights of the citizens we serve.

During this time of stretched resources and fiscal constraints, we find ourselves advocating not only for individuals, but for resources as well.

Presently, more than 8,000 families throughout the state are on a "waiting list" for the placement of a loved one

Already, the group has appointed officers, launched monthly meetings at the Valley Park Adult Training Center, and established clear objectives. Among those objectives are to recommend revisions to the NI Division of Developmental

Those who would like to donate food and personal items for inclusion in the care packages will find collection boxes—decorated by members of the Self-Advocacy Group—situated near the entranceways of the Jerry Davis Early Childhood Center in Manville and the Adult Training Centers in Branchburg, Valley Park, and Green Brook. For a complete list of recommended donations—such as phone cards, baby wipes, drink or soup mixes, and hand warmers—please contact Karen.

"Working with our advocates is inspiring," said Karen. "Their energy and enthusiasm reminds me of what's really important."

Advocacy is more critical now than ever before. "The Self-Advocacy Group is concerned about the increasing amount of money the state is withholding from their disability checks," Karen explained. "The amount withheld has increased from 50 to 75 percent. A person who was receiving \$250 a month, from a total of \$500, is now receiving only \$125!"

Even though the government provides housing and groceries, individuals who have disabilities depend on their disability checks to cover other necessities ranging from toiletries and clothing to furniture and over-the-counter medicines. "What's left in the disability check barely

covers even one of those monthly expenses, not to mention leisure activities," Karen noted.

STANDING UP FOR PERSONAL RIGHTS

"Our advocates are articulating what's important to all individuals who have developmental disabilities, including those who are unable to speak for themselves. Their strength of character and skills are admirable," Karen continued.

"Our advocates have even reached out to other service providers to invite their members to participate in the group's activities."

Officers of the Self-Advocacy Group are Evelyn Ramundo, President; Brian O'Malley, Vice-President; Barbara Cornelius, Secretary; Dawn Prag, Treasurer; and Cliff Pierre, Sergeant at Arms.

In addition to Karen, facilitators include Alison Malnak, Arc Employment Consultant; Kirsten Marri, Support Specialist; and Karen Stanchak, Individual Habilitation Program Coordinator. "We provide assistance," Karen clarified, "but the advocates are driving this process."

Said Lauren Panarella, Executive Director, "We are proud of the Self-Advocacy Group and are confident that they will achieve their mission. We also value the group's leadership in advocacy matters."

Building a Career Path For Direct Support Professionals

The Arc of Somerset County has joined a statewide initiative to build a career path process for direct support professionals (DSPs). The initiative is a pilot project of the NJ Direct Support Professionals Workforce Development Coalition to increase the capabilities, professional skills, and rewards of being a DSP in NJ. Only eight other agencies statewide are participating in this pilot project, which is being funded by a grant from the NJ Council on Developmental Disabilities to reduce the high turnover rate of DSPs.

This partnership between agencies and the state addresses the current crisis involving DSPs, specifically the need to provide them with additional training, a living wage, and incentives to remain in direct care. "Unless there is a clear, voluntary, and accessible statewide process to enhance training and skills—in which competencies are linked with salary increases—there will be no systematic way to provide employees with incentives to remain in the field of providing direct support to people who have disabilities," said a representative from the NJ Direct Support Professionals Workforce Development Coalition.

DSPs who apply and are accepted to participate in the pilot project will enjoy a greater sense of professionalism and job satisfaction derived, in part, from increased knowledge, skills, salary, and recognition. The pilot project utilizes the Internet-based College of Direct Support, and provides a mentor to assist participants in completing their online courses.

"Our hope is that this process will provide incentives to people who would like to remain in direct care, resulting in a reduction in turnover, while, at the same time, enhancing professional skills," said Karen Ennis, Director of Continuous Improvement. Most important, individuals who have developmental disabilities benefit from the increased skills of DSPs, consistency of care, and an increase in dependable caregiving relationships.

Students Partner with Employment Services During "Service Learning Day"

Employment Services hailed this year's annual Service Learning Day with Bernards High School students at the Branchburg Adult Training Center (ATC) on January 18 as the most successful ever. Now in its third year, Service Learning Day gives juniors and seniors from Bernards High School an opportunity to enhance their awareness, sensitivity, and ongoing support of individuals with developmental disabilities. The faculty at Bernards High School has selected Service Learning Day to commemorate Martin Luther King Day and the spirit of serving others.

Students participated in a series of sensitivity exercises designed by members of The Arc of Somerset County staff. The exercises, which simulate some of the challenges experienced by individuals who have developmental disabilities, included putting on a shirt and buttoning it while wearing oven mitts, folding a towel without using your hands, and looking into a mirror and writing your name backwards. After participating in the exercises, the students paired up with consumers to form work teams and complete projects side-by-side for the rest of the business day.



Arc consumers welcomed their new partners with characteristic openness and warmth. Students Ben Fischberg and John Husvethm, who had participated in Service Learning Day last year, expressed how good it feels to work with such kind and friendly people. Ben admired the significant contributions made by people with developmental disabilities, particularly through programs sponsored by The Arc of Somerset

County, while John commented on the respect they shared.

Students Dallas Harvey and Shelby Wojnar, who also participated in the program last year, were equally enthusiastic. Dallas was happy to learn more about people



with disabilities, and to know that he can improve someone else's life through volunteerism.
