# A MESSAGE FROM THE **Executive Director**

Existing services for people with disabilities are in serious jeopardy. This is due in part to continuously eroding funding from the State of New Jersey.



Governor James McGreevey presented his budget proposal on February 27th for the State fiscal year beginning July 1st. That proposal contains a number of items for which The Arc community is very grateful. It also has some items that cause great concern.

First, let's share the good news. The proposal includes the much-anticipated \$7.3 million dollars to fund fifty new group homes for individuals who were promised placement in 2003. It includes \$16.2 million dollars for the "Real Life Choices" program and \$10 million new State dollars for the Early Intervention Program.

In addition, \$9 million dollars are budgeted to address the hazards of lead-based paint. All of these issues are important to The Arc and the people we serve.

Here's where the proposed budget falls short. The proposal includes a 1% increase for all agencies that have contracts with the Department of Human Services. It is the modesty of this increase that is the problem. While

# **New Residential Group Home in Montgomery**

The Rocky Hill Group Home passed the DDD Licensing Inspection on February 19, 2003 and officially opened its doors on February 26, 2003 for one of six proposed consumers. Since that time two additional consumers from the Old Stirling Group Home have moved into the

Rocky Hill home. We will fill the three remaining vacancies as appropriate consumers are identified and as additional staff are hired.

Rocky Hill is a two-story home with three separate double occupancy units. Each consumer has his or her own bedroom.

The first floor has two barrier free units to support four individuals. Each first floor unit has a living room, kitchen, and fully accessible bathroom. The second floor unit is an apartment setting for two individuals with its own living room/kitchen and bathroom.

# WHY BECOME A MEMBER OF THE ARC? One Parent's Story

You may be a parent or relative, or may simply be someone with compassion for those with disabilities. Perhaps you've wondered about joining The Arc. Well, I'm a parent first, and here's my membership story.

Our daughter, Katie, was born in 1992. Initially, she passed all her developmental tests with flying colors. However, my wife, Sarah, with her finely tuned intuition, felt Katie was somehow "different" than our first child, born two years earlier. She was less active, less alert.

We received a diagnosis for Katie of "developmentally delayed" shortly thereafter. Nothing prepared us for the decisions we needed to make, all while dealing with our collective shock and heartache. We had so many unanswered questions. Eventually, we realized that we needed to focus on which organization could most help Katie. We faced the veritable "fork in the road" knowing our daughter's future depended on our course of action.

When our pediatrician recommended we contact the Arc of Somerset County we thought, "not another organization of social worker types." However, when we enrolled Katie in the Jerry Davis Early Childhood program we met many parents, to our surprise, who were just like us. We met Arc teachers who believed that people with disabilities could be empowered to live rewarding and valued lives. We saw the beginning of a positive socialization process for Katie and realized that The Arc is the "go to" organization for people with developmental disabilities in New Jersey. Katie is now eleven years of age and has long since left the early intervention program, but we'll remember how The Arc was there when we truly needed them. In the future when we transition to residential housing

and vocational services, The Arc will be there again.

Why have I supported the Arc by becoming a member? First, The Arc was there for us. Second, The Arc continues to be there for us every day, in Trenton, in Washington, and in our communities. They provide the legislative advocacy for Katie in ways that I, as an individual, cannot. The Arc is a powerful national organization that is our "watchdog" and that seem to be in the middle of every issue. I've also become a member to insure my daughter's future. Someday after I'm gone, various Arc programs like group homes or in a vocational program will care for her. As I stated earlier, I support The Arc through my membership because they stepped up to my plate when I needed information, programs and a positive direction. Today, Katie smiles a lot. Much of her smile and optimism began during her Jerry Davis experience.

When you see a smile from someone you love, think about it. Consider how important it is to become an Arc member, too. The Arc is there for our loved ones; we can be there for them, too. Please, send your membership contribution today.

## "Jacob": A Living Miracle

Success is measured in many different ways. Hopes and expectations may not be the same as what is achievable in reality. But sometimes, miracles happen.

Born premature (3 months early), weighing a mere 1 pound, 7 ounces, "Jacob" needed intensive special care. He spent the first three months of his life in the Neonatal Intensive Care Unit at St. Peter's University Hospital. He received daily nursing care at home for the next 18 months. Jacob had developmental delays, which qualified him for services from the Early Intervention Program (EIP) at The Arc of Somerset County.

Through The Arc's EIP, Jacob received occupational, physical, and speech therapies at his home. Jacob attended the Developmental Daycare at Jerry Davis Early Childhood Center (IDECC) in September of 2000. While there, he continued

to receive two hours of Early Intervention per week. The nurturing, patience and direction from a variety of therapists, teachers, and staff members helped to pave the way for Jacob's success. As his fragile health status improved, he experienced a whole new world. Since his family lived in an apartment complex without a nearby park, he did not have the opportunity to play outside until he attended JDECC Daycare. At first he was frightened and overwhelmed by his playground experience. He had been so sheltered that he had no idea what to do outdoors. Once he became acclimated to playing outside, he craved the sensation of running, climbing, and swinging in the clear fresh air. It was wonderful to see these milestones in Jacob's physical development, but his social and emotional development were still delayed. His inability to communicate effectively compounded his frustration, and resulted in his

isolation from his classmates. Easily frustrated, without the ability to speak, Jacob grunted, gestured, pointed, and cried.

Although Jacob made significant gains developmentally, he was still delayed for his age. When he turned three, he transitioned into the Preschool Disabled program at Jerry Davis Early Childhood Center. He attended school Monday through Friday for five hours and received speech therapy and occupational therapy several times during the week.

The transition was difficult at first. When "Jacob" was upset, he would lash out at others. Self-calming skills were non-existent, which added to his tantrums. He fought with other children, screamed, banged his body on furniture, and lost control of himself. As the school year progressed, Jacob's skills did not improve. When upset, he began to lash out at the staff. Although his cognitive and speech skills were improving, his impulsivity was keeping him from making positive social and emotional progress.

During the summer session his teachers and therapists met to discuss Jacob's skills and developed a plan specifically tailored to meet his developmental goals. In fall 2003, Jacob returned to preschool and began to change and flourish.

All that the staff had been working on to achieve with Jacob seemed to be working. His language skills emerged into sentences with a gentle voice. Even more encouraging was Jacob's newfound ability to react calmly and to use his words when he was frustrated. Along with the success came the willingness to interact with his peers in a positive way. Isolation gave way to parallel play, with Jacob becoming a new peer for his typically developing friends. His Individual Education Plan (IEP) goals were upgraded to incorporate inclusion time in the Private Preschool Program for typically developing children, at the Jerry Davis Early Childhood Center. Today he is actively involved and enjoys cooperative play activities with several students.

# AWARDS & RECOGNITIONS Employee of the Year – 2003

Norma Branker was selected as the 2003 Employee of the Year by a committee of her peers. Norma was employed with Arc from October 1990 until October 1995. After a few years, in August 1998, she resumed her vocation with The Arc in the Ardsley Group Home, as a Support Counselor. Her coworkers describe Norma as a team player with outstanding initiative skills. She plans Arc-consumer parties, uses her own time to organize

group home records and is an invaluable member of the Ardsley Group Home staff. Norma accomplishes all of these things working only 25 hours per week for The Arc, because she is a full-time employee of a different company in New York City!

The Arc Employee of the Year Award was presented at The Arc Staff Holiday Party on December 18, 2003.
